

## MEXICAN ESCAPE TERMS AND CONDITIONS

1. The Mexican Escape entitles the recipient to 4 day/3 night all-inclusive accommodations in Cancun, Ixtapa, Puerto Vallarta or Mazatlan. This package is valid for 2 adults, and does not include cost of taxes, booking and resort fees, gratuities, airfare, ground transportation, or service charges. If you wish to add additional nights, upgrade your hotel, bring additional people or add airfare, this will be quoted at the time of booking.
2. Hotel Taxes and Booking Fees of \$149 USD per package are due at the time of booking and can be paid by Visa, Mastercard, AMEX or Discover.
3. To register your vacation, please fill out the attached registration form in its entirety and send it, along with your \$40 USD registration fee, to: Travel America Vacations, Inc., 1465 Slater Road, PO Box 5007 Ferndale, WA 98248-5007. The \$40 USD registration fee is non-refundable, except where prohibited by law. Only original and completely filled out registration forms will be accepted.
4. Preferred travel date requests must be received in our office with a minimum of 60 days notice. Check-in is valid for Sunday, Monday and Tuesday only. Your desired travel date is subject to availability at the time of booking. Peak travel periods may require a surcharge. Blackout dates apply.
5. Once your registration has been received, you will be advised by email if your preferred travel date is approved and you will be contacted 30 – 45 days prior to travel to finalize your booking. If you do not have email you will be advised by regular mail.
6. This certificate is valid for 18 months from date of purchase by the participating merchant. Travel must be completed before the expiration date on the registration form except where prohibited by law. The expiration date cannot be extended.
7. Only one certificate per family/household/person per year can be used. If two or more certificates are submitted, the additional certificates will be deemed void and unusable. This package cannot be used with any other travel promotions.
8. Travelers must have a valid Mastercard, Visa or American Express in order to check into hotel. For international travel, you must have a valid passport with a minimum of three months validity at time of booking. If you do not have a valid passport, we will not be able to finalize your reservation. Travel America Vacations, Inc. (TAV) may require your passport numbers. In the future, US Customs and Immigration and/or Canada Customs may require passports on domestic travel at which time TAV will require a valid passport to complete reservations for domestic travel as well.
9. This package is not valid for use with group travel. Group travel is defined as more than one certificate holder travelling or meeting at the same destination on the same travel date. Due to the promotional nature of this program, these packages cannot be purchased, bartered, or sold to the end user. Employees or relatives of the participating merchant are prohibited from using this package. Washington Purchasers: You may cancel this contract without any cancellation fee or other penalty, or stated reason for doing so, by sending notice of cancellation to TAV by certified mail, return receipt requested, postmarked by midnight of the seventh calendar day following the day on which this contract is signed by you or the day any membership card and all membership materials are received by you, whichever is later. The day on which the contract was signed is not included as a "calendar day," and if the seventh calendar day falls on a Sunday or legal holiday, then the right to cancel this contract expires on the day immediately following that Sunday or legal holiday.
